

# St. Clair County Transit District Transit Vision 2020 Online Public Engagement Survey Summary

#### 1. Executive Summary

The St. Clair County Transit District is conducting a study, called Transit Vision 2020, of the current transit network in the St. Clair County area. SCCTD hired Transportation Management & Design, Inc. and its sub-consultant Vector Communications to create an interactive online survey to collect the public's thoughts on the existing transit system and how it can be improved in the future.

The survey consisted of five interactive screens that informed participants about the project and allowed them to provide feedback in both closed and open-ended question format. The survey was launched on July 24, 2019 and ran until October 7, 2019. More than 1,200 people participated in the survey and provided 22,000-plus data points and over 700 additional comments.

The first tab was informational and provided respondents with information on the current transit system including the townships currently served, SCCTD's service priorities, and the purpose of this study. The second tab asked attendees about their current travel habits, barriers to using the current transit system, and which groups are in need of better transit service. The survey's third tab asked respondents to decide how they would invest in transit in St. Clair County. The fourth tab asked respondents to show on a map where they conduct their activities including work, school, shopping, and medical centers. The final tab asked respondents to provide demographic information and their travel habits.

The survey respondents represented 80+ zip codes, were mostly African American, between the ages of 26 and 60, and fairly evenly split between male and female. When asked about the current travel habits, a vast majority of the respondents indicated that they primarily travel on the bus or MetroLink. Respondents indicated that they perform most of their day-to-day activities in the areas of Downtown St. Louis in Missouri and East St. Louis, Fairview Heights, Belleville, and O'Fallon/Shiloh in Illinois.

Based on responses to several questions and additional comments, respondents seemed to value safety/security, hours of service, and frequency of service. Respondents indicated that they would benefit most from expanded hours of service and more frequent service. Those respondents who do not currently use transit to travel indicated that increased safety and expanded hours of service could potentially lead them to riding transit in the future. Respondents also indicated that better connections to other services and/or expanding to new coverage areas would also lead them to utilize transit more.

The results of this online survey indicate that respondents value safety and security on transit and desire for more investment in frequency, adding new routes, and expanding hours of service. In addition, when asked which groups would benefit from more transit service in St. Clair County, respondents indicated that both commuters and seniors would benefit from more service; therefore, it will be important for SCCTD officials to further engage these populations as the project continues to better understand their needs.

#### **Transit Vision 2020 Study**

The St. Clair County Transit District (SCCTD), in cooperation with Bi-State Development, has embarked on an operational assessment of Metro Transit's existing St. Clair County, Illinois MetroBus system. This assessment will include recommendations for phased improvements to make service more attractive, productive, and efficient for Metro and its customers.

#### **Public Engagement Online Survey**

A visual and interactive online public engagement survey was created to obtain feedback on the public's priorities and uses of the St. Clair County, Illinois MetroBus system. The online survey was conducted from July 24 – October 7, 2019 and was taken by 1,235 respondents, though not all participants answered every question. The respondents provided more than 22,000 data points and wrote more than 700 additional comments, which are summarized in the following sections.



The above image was the welcome screen, which introduced participants to the Transit Vision 2020 study. The survey was divided into five tabs or screens as follows:

- 1) Study Introduction Provided study background and survey information
- 2) Visual Preferences Gathered input on who and how respondents use transit in Illinois
- 3) Budget Allocation Asked respondents how they would invest money in transit in Illinois
- 4) Map Markers Asked respondents to identify where they spend their time
- 5) Wrap-up Collected Illinois transit usage information and demographic information


On each page, the respondents were: 1) given instructions on "what to do," 2) shown the options to be evaluated with descriptions of each, and 3) given the opportunity to provide comments. As they made selections and entered answers, the "Progress" bar at the top of the page would become more complete.

The remainder of this document outlines the results of the online public engagement survey.

#### 3. Online Survey Results


#### **Respondent Demographics and Travel Habits**

Although the following set of questions was asked on the final page of the survey, the data is at the top of this summary section to provide information about the respondents. Knowing the respondents' travel habits and demographic information helps put their comments into context and shows representation across a range of Illinois transit users, including those with the most stake in the study.






The majority of respondents (64% or 656) travel on Illinois transit five or more days per week, which indicates most respondents who use transit likely use it to travel to and from school and/or work.

# Question: "What is your zip code?"




Respondents represent 80+ zip codes. The zip codes with the most respondents are 62205 (99), the East St. Louis, Illinois area, 62221 (99), the Belleville, Illinois area and east of the city, 62220 (97), the area southwest of Belleville, 62226 (86), northwest of Belleville, and 62269 (73), the O'Fallon, Illinois area.


Question: "What is your gender?"



Most respondents identified themselves as Black or African American (58% or 583 people).





#### **Visual Preferences: Key Groups**



Respondents indicated that both commuters (34% or 385 people) and seniors (29% or 334) would benefit most from more transit services in St. Clair County.









Respondents cited safety concerns (38% or 415 people) and limited hours of service (24% or 261) as the main issues preventing them from using St. Clair County Transit.











Respondents indicated that better connections to other services (29% or 315 people), expanded hours of service (28% or 299) and more frequent service (27% or 288) would lead them to utilize transit more.







#### **Budget Allocation**



On the budget allocation page, respondents were asked to decide how they would invest in transit in St. Clair County by dividing coins among the following categories (with accompanying descriptions):

- 1) Key Bus Routes Run Every 15 Minutes Key bus routes will run more frequently, every 15 minutes
- 2) 30-Minute Service on Bus Routes 30-minute service on all routes would standardize the system, making it easier for riders to anticipate when their bus will arrive.
- 3) Earlier or Later Hours of Service Bus Routes starting earlier or ending later
- 4) Weekend Transit Service More bus routes operation on Saturday and Sunday or bus routes running longer hours on Saturday and Sunday
- 5) Expand Bus Service to New Areas Expand coverage to new areas such as new destinations within St. Clair County, Madison County, Monroe County, Missouri Routes
- 6) More Service to Employment Hubs More service to major employers and employment hubs such as: St. Elizabeth's Hospital, Memorial Hospital, and Belleville Boot
- 7) First/Last Mile Services Partner with companies that provide first and last mile services (mobility on demand, bike, scooters, employer shuttles)
- 8) Investments in Bus Stop Amenities Invest in bus stop amenities like shelters, benches, bike racks, Wi-Fi, etc.

Respondents were allowed to invest 40¢ total but could determine how this was distributed between 5¢ and 1¢ coins. Respondents were also allowed to choose whether to invest all of their coins in one category or divide them among several categories.

The chart below outlines the respondents' investment into each category with the highest being "Key Bus Routes Run Every 15 Minutes" receiving 7,745 coins or 19% of the total invested, and the lowest being "First/Last Mile Service" receiving 2,445 coins or 6% of the total invested.




#### **Map Marker**

- Other




There were 2,435 total markers placed on the map, the majority of which were concentrated in the areas of Downtown St. Louis in Missouri and East St. Louis, Fairview Heights, Belleville, and O'Fallon/Shiloh in Illinois.

A majority of respondents indicated that they live in the areas of Belleville, Swansea, East Saint Louis, Cahokia, and Washington Park in Illinois.



A majority of respondents indicated that they attend school at Southwestern Illinois College or in the Belleville area.



There were 530 work markers placed on the map.



Responses for work locations were fairly spread out across Illinois and Missouri counties with the most concentration being in the areas of Downtown St. Louis in Missouri, Fairview Heights, Belleville, O'Fallon, Scott Air Force Base, and Pontoon Beach in Illinois and the Central West End in Missouri.



Responses for shopping were also fairly spread out across IL and MO counties however a large portion of the responses (207) were in the Fairview Heights area.







#### 4. Conclusion

On the final screen, respondents were asked to provide their email address for future communications and were provided with links to access more information or contact SCCTD.



The online public engagement survey indicates what improvements respondents would like made to use the St. Clair County Transit District system and to use it more often. According to respondents, to attract new riders, transit district officials should improve safety and the system's hours of service. Additionally, to get current riders to use the system more often, officials should provide better connections to other services, expand hours of service and provide more frequent service. In fact, respondents indicated a desire for Transit District officials to invest in increasing service times on key bus routes and to add routes to new areas.

Respondents also indicated a need for transit to be more accessible and convenient for commuters (coming in and out of Illinois) and seniors. It will be important to engage further these populations in the future to ensure their needs are met.
